





Kevin leaves abruptly and I'm now chatting with a third technician and her name can be intentional but I'm not sure yet.


So at this point, I had already adjusted the settings and it took way less than 48 hours to update, so I could finally visit my blog using "emema510.com" and not only the temporary gibberish URL and the "nocache" URL, but the issue was only half solved. I wasn't aware of the issue until later, but the issue was only "emema510.com" was working and not "www.emema510.com" and yes, apparently there's a difference.

dafuk!?


Error logs!? What error logs? It's an issue with the settings.
